SOMEC: from USA new orders worth 36 million US\$ in the building segment

Somec S.p.A., a company specialising in the engineering, design and construction of large turnkey projects, in the shipbuilding and civil construction sectors, with regard to glass cladding, special architecture projects, outfitting for public areas and catering for large kitchens, listed on the AIM Italia Market, has acquired new orders worth more than 36 mil US\$, for the Landscape – Building Façades division.

Somec group, through Fabbrica LLC, has been awarded three new projects for the design and manufacturing of the curtainwalls for office buildings. Two projects are located in Boston, Massachusetts: a 28-story office tower with a glazed surface of more than 250.000 square meters with expected delivery in 2023 and an office building that features a terracotta and glass façade curtainwall, with expected delivery in 2020. The third project, in Chelsea, Manhattan, it's a 10-story boutique office along New York's famous High Line, with delivery expected in 2021.

Just two weeks since the entrance in the Group, Fabbrica Works is operating on the manufacturing of the glazed modules for the projects expected in 2020 and 2021. Through Fabbrica Works Srl and the start-up of the European manufacturing branch in the Building Façades segment, Somec can leverage on another production and development centre to offer a full service to projects that stand out for the care in the engineering and manufacturing phase, in line with the identity of FABBRICA LLC. Moreover, the building segment can count on three design and engineering centres: in Windsor – Connecticut, Montreal – Canada and Treviso -Italy (where Squadra Srl is based). Overseeing the entire value chain, from designing, through manufacturing until the installation, is the Group strategy to sustain the strong growth in the USA building segment and obtain a leading positioning in the Building Façades segment.

The new orders are the first acquired by the Group in 2020 and sum up to an amount of 120 million Euro from the 2019 second half order intake (30.06.2019 backlog for 552 million Euro).
