

## SOMEC AWARDED WITH 14 MILLION EURO OF ORDERS FOR THE FOUR SEASONS CRUISE FLEET

## Fincantieri commits to OXIN, part of the *Professional Kitchen Systems and Products* division, the realization of the catering areas on new luxury cruise ships

San Vendemiano (Treviso, Italy), 18 April 2023 – Somec S.p.A. (Euronext Milan: SOM), specialising in the engineering, production and commissioning of complex turnkey projects in the civil and naval engineering sector, announces that its Professional Kitchen Systems and Products business unit has obtained orders worth 13.7 million euro from Fincantieri.

The agreement involves the subsidiary OXIN S.r.l., specialized in the design, production, installation and maintenance of kitchen systems on passenger ships and large yachts, and consists of a total of 3 orders, 2 of which are in option, for the Four Seasons cruise fleet.

In detail, the contract relates to the catering areas of a ship commissioned by the luxury cruise operator Four Seasons, to be built at the Ancona shipyard. On the vessel, 207 meters long and equipped with 14 decks, the surface area destined to catering will exceed 1,100 square meters, with 3 kitchens and numerous bars which, like the restaurants and lounge areas, will be equipped with state-of-the-art OXIN products and solutions. Delivery is scheduled for the end of November 2025 for a total amount of 4.6 million euro.

Also the two additional options, worth a total of 9.1 million euro, are related to complete solutions for the catering areas. Delivery is scheduled for 2026 and 2027, respectively.

Oscar Marchetto, Chairman of Somec, underlines: "The renewed trust of a consolidated and prestigious partner such as Fincantieri is a source of great pride for our workers and for all of us. With these orders, which arrive just a few days after those entrusted to Mestieri by leading international cruise operators, our Group confirms itself capable of playing a primary role in the naval sector, thus responding to the dynamism of latter, which - particularly in Italy - proves to be a driving force".
