

SOMEC: MESTIERI AWARDED NEW NAVAL INTERIORS CONTRACTS EXCEEDING 21 MILLION EURO

TSI selected to supply bespoke interior solutions for luxury vessels operated by a leading US shipowner

San Vendemiano (TV), 22 December 2025 - Somec S.p.A. (Euronext Milan: SOM), specialising in the engineering, production and deployment of complex turnkey projects in the civil and naval sector, announced that it secured new contracts worth more than 21 million Euro through its *Mestieri: Design and Production of Bespoke Interiors* business unit. The contracts relate to next-generation cruise vessels commissioned by a leading luxury-segment shipowner.

The orders, consisting of three contracts—one of which is under option—have been awarded to the Group's subsidiary TSI – Total Solution Interiors by a major Italian shipyard. They cover the supply of fully bespoke, turnkey furnishings for two extensive speciality-restaurant areas on each vessel. Designed to deliver a premium dining experience, the spaces are defined by a distinctive design identity, reflecting the highest standards of service.

The works will cover wide areas, spanning approximately 2,100 square metres per vessel, and will involve a high degree of customisation, design complexity and execution quality, in line with the highest industry standards.

The vessels are scheduled for delivery between 2028 and 2032, with the financial impact of the contracts extending from 2026 through to 2032.

Oscar Marchetto, Chairman of Somec, said: "These orders come at a time when the cruise sector remains dynamic, with demand driven more and more by quality, customisation and the overall on-board experience—areas in which interiors are playing an increasingly key role in shipowners' offerings. Against this backdrop, Mestieri and TSI strengthen their position as partners capable of delivering complex, bespoke projects, contributing to the creation of high-value spaces that enhance both the vessel's identity and the overall on-board experience for guests."
