

SOMEC: MESTIERI SECURES NEW HIGH-END INTERIOR AND ARCHITECTURAL ORDERS WORTH OVER 13.5 MILLION EURO

Specialty doors and windows and metal architectural structures growing within premium segment projects

San Vendemiano (Treviso), February 2, 2026 - Somec S.p.A. (Euronext Milan: SOM), specialising in the engineering, production and deployment of complex turnkey projects in the civil and naval sector, announced that it secured a series of new orders covering high-end interior projects, specialty architectural structures, and premium cladding solutions through its *Mestieri: Design and Production of Bespoke Interiors* business unit. The new orders, worth over 13.5 million Euro, include work for leading international retail —mainly in the fashion sector— and hospitality brands located in prominent destinations. Together, they reinforce the Mestieri unit's strong position in the highest value-added segments of the market.

The projects involve the subsidiary companies Budri, Gino Ceolin, Lamparredo and Skillmax and will be carried out in Italy and the United States, in cities such as Venice, Rome and Milan, as well as exclusive locations in California. They span high-profile hotels, iconic boutique spaces and premium workplaces, reflecting the Group's growing integration and the increasingly close collaboration among its companies.

At their core, these are highly bespoke projects that draw on the full range of expertise within the Mestieri business unit. They include marble and natural stone cladding (Budri), complex metal architectural structures (Gino Ceolin and Lamparredo) —from high-performance specialty doors and windows to façades and monumental staircases— and exquisite custom furnishings (Skillmax).

A particularly significant share of the new work concerns bespoke steel and bronze window and door systems, a strategic area of development for the business unit and a key driver in the evolution of Mestieri's offering towards more refined and specialised solutions.

These orders follow the Mestieri contracts announced in December 2025, worth over 21 million Euro, and further strengthen the unit's order portfolio, highlighting the Group's ability to deliver international projects across multiple luxury segments.

The economic impact of the orders announced today is expected to be fully reflected in the 2026 financial year.

Oscar Marchetto, Somec Chairman, pointed out that: *"These new orders show how the Mestieri business unit is moving towards increasingly complex projects, where the expertise of our subsidiaries come together to create unique, bespoke solutions. It's a level of craftsmanship that transforms materials and technologies into results of exceptional quality. Specialty steel and bronze doors and windows are an area where we are investing with clear intent, in line with a growth strategy focused on highly specialised, high-complexity projects. It's an approach that brings together Made in Italy excellence, industrial control, and strong execution capabilities, resulting in exclusive solutions for prestigious architectural settings".*
