SOMEC: ADDITIONAL NAVAL GLAZING ORDERS WORTH OVER 28 MILLION EURO

San Vendemiano (Treviso), September 22, 2026 – Somec S.p.A. (Euronext Milan: SOM), specialising in the engineering, manufacturing and installation of complex turnkey projects for the civil and naval sectors, announces the acquisition of new orders and the update of existing agreements, with an aggregate value of over 28 million Euro.

The contracts, awarded to the *Horizons* business unit (*Engineered Systems for Naval Architecture and Building Façades*), relate to glazing systems for new-build cruise ships, commissioned on an ongoing basis by a leading shipbuilding group on behalf of a major international luxury cruise operator, as well as the integration of existing contracts for the same series.

The work on the new vessels covers the design, manufacture and installation of complete glazing systems, including windows and doors, redesigned balcony solutions in terms of both dimensions and concept to serve as a natural extension of the suite spaces, and glazing for public areas and the bridge. These features play a central role in the architecture of this segment and contribute directly to the quality of the onboard experience.

These ships operate in the top tier of the global cruise industry and are compact in size with limited passenger capacity. Their design highlights the sophistication of the spaces, the personalised service, and the value of the destinations whilst prioritising technological innovation and sustainability.

The project will be executed between 2027 and 2035, with the financial impact being distributed over this period.

Oscar Marchetto, Chairman of the Somec Group, has commented: *'In the ultra-luxury cruise segment - a sector experiencing rapid and sustained growth - passenger numbers are deliberately limited and every space on board is carefully designed to maximise the passenger pleasure. In this context, glazing systems are not merely functional components, they are features that passengers see, touch and pass through every day. Somec is responsible for contributing to the unforgettable journey that shipowners create for their customers, an experience built on small yet significant details, on every single voyage. More generally, this new contract further demonstrates Somec's ability to leverage its distinctive expertise to unlock growth opportunities, while enhancing the visibility of its order backlog, which currently stands well above 1.1 billion Euro, as highlighted in recent corporate announcements.*

The confidence placed in Somec by the market, across both the civil and naval sectors, underscores the strength of the Group's international positioning and reflects its recognition as a partner of choice for the execution of complex, high-value-added projects.'
